POL#02 Safety Policy

Kym Clarke Constructions accepts its moral, legal, and social responsibility to provide a safe and healthy workplace for all employees, sub-contractors and visitors.

Kym Clarke Constructions are committed to:

- ensuring compliance with National and State legislative requirements and current Industry Standards
- providing and maintaining safe systems of work
- establishing measurable objectives and targets to ensure continued improvement aimed at elimination of work-related injuries and illness
- providing and maintaining written procedures to comply with safety requirements

Sub-contractors are responsible for:

- ensuring their employees comply with relevant National and State legislative and industry requirements
- ensuring their employees use relevant safety equipment and hold current applicable licenses / qualifications for tasks carried out.
